ELIGIBILITY:

- 1. Must be dependent children of a member or retiree of Local Union 1938, United Steelworkers U S Steel Corporation, (Minntac plant).**
2. Dependent children of members who were in good standing at the time of their death or retirement.
3. A "member" is defined for this purpose as one currently paying dues or exonerated from dues payments in compliance with Article XIV of the International Constitution.

AMOUNT OF PAYMENT OF AWARDS:

1. Ten (10) - \$750.00 scholarships. Scholarships will be issued on a point system; including G.P.A., school activities as well as outside activities such as employment*. **(*Employment must be verified by signature of employer).**
2. Should a selected student not enter college, university or vocational technical institute, the next highest shall be granted said scholarship.
3. Student Scholarship will be paid directly to college, university or vocational technical institute of their choice, which is a recognized and accredited institution upon registration. Checks are made out jointly to the school and student. We will contact you mid-August to verify the school, and checks will then be made out.
4. **Student Advisor shall send application by mail on or before March 31, 2021** to Steelworkers Local 1938 office to be eligible. **(Postmark must be no later than March 31, 2021.)**
